Finance Highlights

- Income up from 2022 by £800 (Membership slightly down despite fees increase)
- New Income streams from Bank interest and Easyfundraising raised £750
- Lighting Electricity costs were fully offset £1000 P.A.
- New charges implemented for LTA Home Match fees;
 - Summer £4 per team member
 - Winter £6 per team member

To cover costs of LTA entry fees, new balls and lighting

- One off cost of £4,200 for new steps and pathway from carpark to the courts – completes our planning obligations from building the Pavilion in 2018
- Reserve Funds increased by £4,700, only £700 below budget.

Chairman's Report cont:

LTA Tournaments:

Well done to our LTA Team players – in particular the A Team who won the Gloucestershire LTA B1 League.

We had 6 teams in various leagues during last Summer and 3 in the winter league

Finance

- We have a target in 2026 to resurface the courts.
- To do this we budgeted £42k for new asphalt courts.
- Current estimates now indicate a cost of £50k+
- We currently have reserves of £27k, with 3 seasons to raise the balance.

Alternative surfaces: Clay, Artificial Grass & Carpet, some of these are considerably cheaper to install than our current surface.

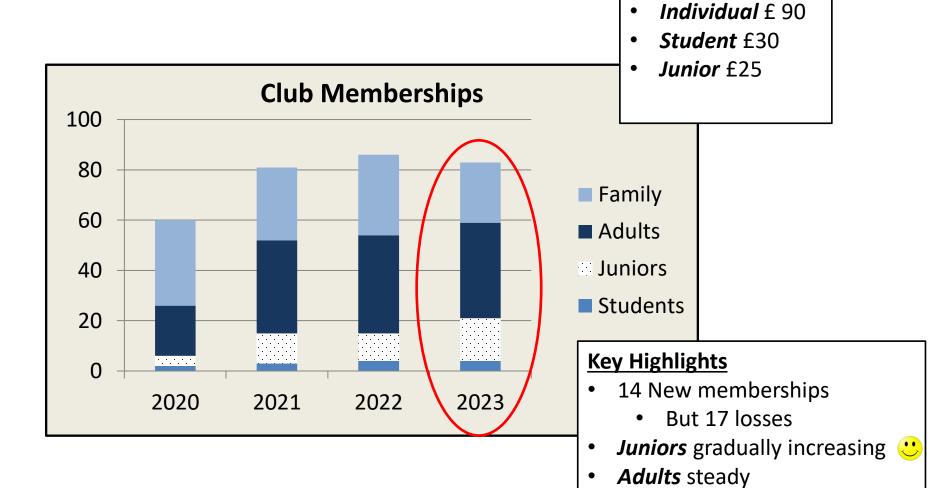

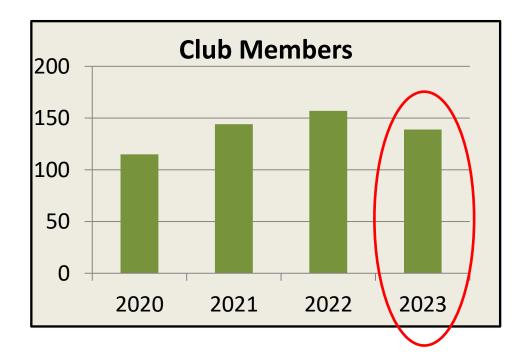
